Purpose of collection

SICE NZ Limited NZBN:9429030898240 (SICE, we, us, our) is collecting your personal information in order to comply with our legal and regulatory obligations, to provide you with products and services, respond to your enquiries, create and maintain your account, and to administer and manage our relationships with suppliers, customers, and other stakeholders. If you don't provide this information, we may not be able to comply with our legal and regulatory obligations and provide you with requested products or services. Personal information we collect will be treated strictly in accordance with the Privacy Act 2020, along with the Information Privacy Principles contained in both Privacy Acts and our Privacy Policy.

For the avoidance of doubt, it is possible that the overseas recipients may not be required to protect the information in a way that, overall, provides comparable safeguards to those in the Privacy Act 2020 (as applicable). However, where possible, we try to enter into agreements with the overseas recipients to ensure comparable safeguards.
