

PRIVACY COLLECTION STATEMENT (NZ)

Purpose of collection

SICE NZ Limited NZBN:9429030898240 (SICE, we, us, our) is collecting your personal information in order to comply with our legal and regulatory obligations, to provide you with products and services, respond to your enquiries, create and maintain your account, and to administer and manage our relationships with suppliers, customers, and other stakeholders. If you don't provide this information, we may not be able to comply with our legal and regulatory obligations and provide you with requested products or services. Personal information we collect will be treated strictly in accordance with the Privacy Act 2020, along with the Information Privacy Principles contained in both Privacy Acts and our Privacy Policy.

Disclosure of your personal information

We may disclose your personal information to third parties, such as our suppliers, contractors and organisations that provide us with technical and support services, and to our related entities (who may use and disclose the information in the same manner we can), as more fully described in our Privacy Policy. We may also disclose your personal information to regulatory bodies such as where this is required by law.

We usually do not send personal information outside of New Zealand. However, in some situations, we may disclose personal information to overseas recipients, located in the following countries: Australia, the United Kingdom, Spain and the United States of America.

By providing your personal information to us, you consent to us disclosing your personal information to any such overseas recipients for purposes necessary or useful in the course of operating our business. For the avoidance of doubt, it is possible that the overseas recipients may not be required to protect the information in a way that, overall, provides comparable safeguards to those in the Privacy Act 2020 (as applicable). However, where possible, we try to enter into agreements with the overseas recipients to ensure comparable safeguards.
